This N.A.To^{*} will be held from 17-21 July 2024 (Arrival on 16 July) in Visalaje and Ostrava, CZ.

You may know the Nose Assembly for Tomorrow* (N.A.To*) and you might want to continue in our colorful experiments with activism and clowning. You may heard about N.A.To* and you might be keen on joining. In both cases, you are welcome!

The next N.A.To* will be held in Czechia and it will focus on deepening the tools and methods from previous assemblies. We are going to collectively work on the toolbox of N.A.To*. Are you ready to jump aboard (again)?



PROGRAM

The N.A.To* #5 focuses at collectively creating the N.A.To* toolkit and deepening methods and approaches we explored during previous assemblies (Theatre of the Oppressed, Soundpainting, "Traditional" clowning practices and others).

The assembly will be organized as a working meeting of affinity groups. Each group will focus on a specific topic(s), clowning tools and methods that shall be deepened and opened in the toolkit. The program is open for you to co-create. It is up to you whether you want to philosophize clowning activism, develop clowning exercises or dance (with pigeons and plastic bags). One affinity group will be focused on the methods of "Gravity strike" and it will be facilitated by Florent Golfier-Brechmann. The affinity group will be also focused on co-creative street practice of "Clown office invasion", which will be tested in the streets of Ostrava. Amount and focus of the other affinity groups remains open. So it is up to you whether you want to propose a topic, form your own affinity group or join some other group.

The program will consist of affinity group working sessions, plenaries, sharing of findings among affinity groups, trips to nature, collective cooking and living.
